RELEASE AND WAIVER OF LIABILITY

The individual(s) named below (jointly, "I") certify that I am the owner of (dog's name(s)) _____ (each, a "Dog"), which will participate in training and socializing services (the "Services") to be provided by Michele Kondos of Kindred Canines, LLC ("Kindred"). As a condition to Kindred providing its Services, I agree to all the terms and conditions set forth in this Release and Waiver of Liability (this "Release").

I am aware and understand that the services are potentially dangerous and involve the risk of serious injury, disability and/or death to/of the Dog and other animals or people, as well as property damage, arising from the Dog's participation in the Services. I acknowledge that any injuries or damages may result from or be compounded by the actions or omissions of Kindred or its representatives, including (without limitation) emergency response or rescue operations. Notwithstanding the risk, I am voluntarily permitting the Dog to participate in the Services with knowledge of the risks involved and hereby agree to accept and assume any and all risk of injury, disability, death and/or property damage arising from the Dog's participation in the Services, whether or not caused by Kindred.

I hereby expressly waive and release any and all claims, whether now known or unknown, against Kindred, and its officers, managers, employees, agents, representatives, owners, successors and assigns (including, without limitation, specifically Michele Kondos) (collectively, the "Releasees"), arising out of or attributable to the Dog's participation in the Services, regardless of cause. I agree not to make or bring any such claim against Kindred or any other Releasee, and forever release and discharge Kindred and all other Releasees from liability under such claims. This waiver and release extends to claims for gross negligence, willful misconduct, or any other liabilities, except those that the laws of Pennsylvania do not permit to be released by agreement. I hereby consent to the Dog receiving veterinary treatment deemed necessary if it is injured or requires veterinary attention during its participation in the Services when I am not present to give specific consent. I understand and agree that I am solely responsible for all costs related to such veterinary treatment and any related medical transportation and/or evacuation. I hereby release, forever discharge, and hold harmless Kindred and any other Releasee from any claim based on such treatment or other veterinary services. I understand and agree that genetics and environmental history (e.g., past experiences, lack of training, nutrition, health, etc.) can affect my Dog's behavior. I understand and agree that this training may not be able to cure my Dog's aggression, or other problems, and I further understand and assume all risks associated with owning and harboring a dog that may be aggressive. I agree that Kindred does not guarantee that my Dog will do or stop doing any specific behavior after training; Kindred offers follow up support as long as I own my Dog.
